## 100<sup>th</sup> Anniversary

As you know, in 2020 our branch turned 100! And as with many celebrations during the pandemic, they were either cancelled or put on hold. I am excited that as a branch we are moving forward with our 100<sup>th</sup> Celebration, "Looking Back, Moving Forward"! May 6<sup>th</sup> at 5:30 we will host a happy hour event. Yes, it will be online – a webinar, as it is still not yet safe to gather in person. More information can be found in this issue of the newsletter, but it's important that you know that this event is not only for AAUW members, but our community partners, our friends and family are invited to attend! Do you know someone you would like to introduce AAUW to? You can invite them. There is no charge!

As we get a little closer, you will receive an invitation via email. Feel free to forward it to a friend or family member whom you think might be interested in learning more about AAUW. Upon registration, a link for the event will be sent.

## Membership Vote

AAUW's annual election will be open April 7 – May 17 (5:00 PM). Included in the vote is a proposal to open membership to anyone who supports the mission of AAUW. This requires a change to AAUW's national bylaws through member vote. Our national leadership, state leadership and both of your branch presidents are supporting this change. Please read the following as you consider your vote.

*You may wonder how might this bylaw change affect my branch?*

It will help protect the future of AAUW by opening up opportunities for funding. Because our current educational degree requirement can be deemed discriminatory and not in keeping with our mission, some foundations and corporations will not donate to our organization, since it is counter to their criteria of equity.

It will make it easier for our branch to recruit a more diverse membership, including those who did not have the opportunity to attend college 30, 40 or 50 years ago. In addition to possibly increasing membership, these new members may bring new energy and viewpoints critical to our branch's ability to meet the needs of our community through our mission. It will also remove the embarrassing situations when you must tell someone she/he does not qualify. (Our membership VP has expressed this concern).

It will update the relevance and image of our branch as the world reckons with inequality and systemic racism, much of which disproportionately affects women.

It might open up more opportunities for collaboration. Having a limiting membership requirement can be considered discriminatory and off-putting to other local, like-minded groups.

Today, there are more alternatives to college degrees, which have burdened women with two-thirds of the national college debt. With more careers open to women, i.e., firefighters, pilots, entrepreneurs, artists, politicians, manufacturers, retail managers, and more, our branch may have the potential for a variety of new members.

*What won't change if this passes?*

It will not affect AAUW's status as one of the leaders in graduate grants and fellowships. Due to the generosity of our members our fellowships and grants are fully endowed and will continue in perpetuity.

It will not affect the name – AAUW. Like the YWCA and NAACP, much of the original meanings are no longer accurate. We have been open to individuals with associate degrees, not just degrees from universities, since 2005 and open to men since 1987.

It will not affect the honor of having earned a degree in times when so few women attained this achievement. Today, with women outpacing men in earning all degrees for decades, we can be proud that we were instrumental in breaking down the barriers for women who followed us.

It will not affect the uniqueness of AAUW. Its uniqueness is its breadth of programming, research, policy, advocacy, fellowships and grants, and grassroots membership. It will not change our branch's involvement in local scholarships or interest groups.

It will not change the mission of the branch. Mission is not determined by a degree, but in belief in and dedication to equality for women.

*Each vote matters. Please vote April 7- May 17.*

### **AAUW Illinois State Convention**

This year our state convention (a merging of the Northern and Southern Districts) will be April 23 – 24 via Zoom, with the theme "Equity Empowers – Speak Out for Equity!" Here is the plan:

**Friday evening 4/23:** The convention kicks off with **Michelle Duster**, great-granddaughter of Ida B. Wells. Ms. Duster's program will focus on confronting systemic racism.

**Saturday 4/24:** Begins with an AAUW update. **Gloria Blackwell**, Vice President for Programs and Advancement will Zoom in from our National office.

We will conduct our Annual Business Meeting and have two additional speakers, **Kimberly Stratton** and **Dr. Gretchen Goldman**. Ms. Stratton is an engineer and will focus on STEM. Dr. Goldman will speak about the impact of the pandemic on women.

The Spring edition of LINK will be coming out late March with convention details.

**Attending the convention will be completely free**, but you will, of course, need to receive the link to join the meeting. Watch for an early April special edition of the CONNECTION email for more information.

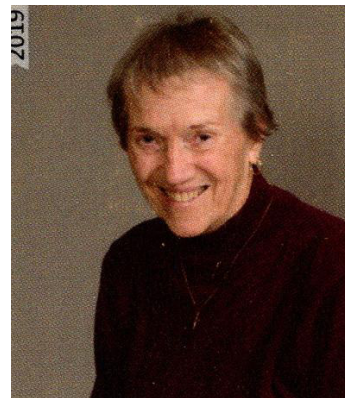
Dues are \$85. (Exception - for the four members who have paid-up national dues for their lifetime the dues are \$23.)

## Public Policy

**Local Candidate Forums:** The League of Women Voters Elgin Area is conducting candidate forums for local elections. The forums are being recorded from Feb. 16 to March 16. They included candidates for Elgin City Council, ECC board, Gail Borden Public Library board and U-46 board. After recording, they are posted at [lwvelginarea.org](http://lwvelginarea.org).

The following information on bills is in no particular order.

### Illinois Legislation

**HB559 & HB560 Amend the Biometric Information Privacy Act (BIPA).** According to ACLU of Illinois in a 3/8/21 email, these bills would end many of the protections in BIPA. B559 is in its second reading in the IL House. HB6560H has been referred to the Judiciary Civil Committee.

**Parental Notice of Abortion (PNA):** AAUW-IL is urging repeal of PNA. In a 2/19/21 email, Tracey Sherman-Falcon and Paula Purdue, Public Policy Co-Chairs, AAUW IL said AAUW supports the right of every woman to access safe, affordable, and comprehensive reproductive healthcare, and this includes youth. We need to tell our legislators to trust youth with their own health decisions.

### Federal Legislation

**Violence Against Women Reauthorization Act:** The House passed this legislation that provides services for survivors of domestic violence, dating violence, sexual assault, stalking, allocates funding for victim services and the health care system's response to domestic abuse, improves access to housing for survivors, and reduces the risk of firearms turning abuse deadly.

**Equal Rights Amendment (SJRes1):** On March 17, the US House of Representatives voted to advance the Equal Rights Amendment by removing its arbitrary ratification deadline. This is an important step towards adding the ERA to the Constitution and creating a more equal democracy. The Senate now needs to pass it. LWV email on 3/17/21. In a 3/21/21 email, AJ Conroy reported that North Dakota has rescinded its ratification. This issue will be litigated.

**For the People Act (HR1):** This Act would improve the country's campaign finance and government ethics laws, while restoring voting rights to disenfranchised Americans. For example, this bill would strengthen Federal prohibitions against foreign contributions in American elections, require that every president of the United States disclose tax returns and prohibit politicians from using taxpayer dollars to settle harassment claims. From Sen. Tammy Duckworth's letter, 3/18/21.

**Equality Act:** This Act would amend existing federal civil rights laws to provide explicit protection against discrimination based on sexual orientation and gender identity.

The Equality Act passed the U.S. House of Representatives with bipartisan support. It awaits Senate action. *AAUW Washington Update*, 3/5/21.

***Police Training and Independent Review Act.*** *Sen. Tammy Duckworth has introduced this bill* to require training for law enforcement officials on fair and impartial policing as well as best practices for working with members of the community with disabilities or mental health conditions. It also encourages communities to use independent prosecutors to investigate law enforcement officials' use of deadly force.

***Hate Crimes Commission Act:*** *Rep. Raja Krishnamoorthi reintroduced this bill* that would create a bipartisan commission to investigate the rise in hate crimes, potential causes of that increase, and how to combat it. This commission would provide us with the data and analysis we need to address the rise of hate crimes.

***Choosing Our Own Lives Over Fast Firearms (COOL OFF) Act.*** This bill aims to reduce gun violence by requiring a three-day waiting period for all handgun sales. It was reintroduced by Rep. *Raja Krishnamoorthi*.

***Family and Medical Insurance Leave (FAMILY) Act*** (S. 248/463). This bill would guarantee workers with 12 weeks of paid leave at up to 66 percent wage replacement, and this permanent benefit would be funded through minimal employer and employee payroll contributions. Sen. Duckworth used S. 248 as the bill number; Sen. Durbin used S. 463.

***Build America's Libraries Act (S. 127):*** This legislation would provide **\$5 billion** in funding to repair, modernize, and construct library facilities in underserved and marginalized communities.

***Paycheck Fairness Act (S.270):*** The bill has already been reintroduced in the 117th Congress with broad support. *AAUW Action Fund Washington Update*, 2/11/21.

***Raise the Wage Act (H.R. 582/S. 150)*** Raising wages has never been more urgent than during the pandemic. The continued stagnation of the minimum wage, combined with the COVID-19 crisis, has reinforced and widened racial and gender wage gaps. Ensuring all workers receive a fair wage is a matter of gender and racial justice. *AAUW Action Fund Washington Update*, 2/11/21.
