## Co-President's Report

From Marlene Daubert and Rosemary Dyson

*As we write this, our two years as your co-presidents are coming to a close. Even though we will continue for one more year, we have decided for this newsletter to each write a few reflections.*

### Marlene Daubert speaks her mind.

This has certainly been a time like no other. Zoom, almost unknown by most of our members 14 months ago, has been a way to stay in community—to have a picnic together, hear

speakers, share in meaningful conversations about privilege and diversity, board meetings, discuss books and movies, and so much more! You have been a resilient group and open to new things. We don't quite know how we will move forward yet, but this shows that we are able to change and be open to new ways of doing things as we move into our next chapter.

I (Marlene) recently watched a Ted Talk by Amanda Gorman, the amazing young woman who wrote and delivered the poem, “This Hill We Climb” at President’s Biden inauguration. She says she always asks her students two questions. The first, “On whose shoulders do you stand?” What a great question to consider as we think of those who have gone before and from where we have come. This became very evident at our 100th Anniversary celebration. (By the way, if you haven’t seen it, you will find a link on our website). From voting rights, to leaders in all aspects of society, to educational opportunities and so much more! We stand on the shoulders of the multitudes of women and allies that have come before us. On whose shoulders do you stand?

Her second question is this, “For what do you stand?” What is important in your life for which you are willing to take a stand? What an important question that helps to guide the way we spend our time, our resources, to speak out, to stretch ourselves, to take leadership responsibilities. What is on your list? I wonder if helping to pave the way for equity for women, educational opportunities for girls and women, STEM, other aspects of AAUW is on your list? Based on your answer, there will be others who follow us that may point to us as shoulders for which they stand on.

Having said that, as we move forward, we need to continue to be relevant. We need members willing to step into leadership roles that will continue to move us forward. We will continue to empower women and girls. We will continue to give voice to the things that matter specifically to the challenges of women. We will support and encourage one another. Please consider, for what do you stand? And then take a stand.

### Rosemary Dyson has a few things to say.

First and foremost, I need to answer the following question. Why is Rosemary Dyson an active participant in the American Association of University Women? I found that answer on AAUW website page. It says, “We are tenacious and trailblazing advocating for women and girls since 1881 and into the future.” I have found a group of like-minded women who believe in the absolute equality of all women regardless of age, race, ethnicity, or culture.

### *We’ve come a long way, but we also have a long way to go in order to achieve full equality.*

There are abundant examples of the move toward full equality for women and girls. AAUW has published hundreds of research reports, from an 1885 paper disproving a prevailing myth that college impairs a woman’s fertility to, most recently, a study documenting the economic impact of workplace sexual harassment. We have supported the academic achievements of many thousands of scholars, from

scientist Marie Curie, the first woman to win a Nobel Peace Prize, to astronaut Judith Resnik, the second woman to travel in space.

Our advocacy efforts have propelled countless new laws, including the Equal Pay Act, first proposed in 1945 and finally passed in 1963; the Title IX amendment in 1972; the Family and Medical Leave Act in 1993; the Lilly Ledbetter Fair Pay Act in 2009; and the Paycheck Fairness Act, which was passed by the U.S. Representatives in 2019 but is awaiting action in the Senate.

***We still have work to do.***

Women make up almost half of the U.S. labor force. They outnumber men in earning bachelor's and master's degrees and are nearly on par in getting medical and legal degrees. Yet from the corporate boardroom to Congress, from healthcare companies to the courts, from non-profit organizations to universities, men are far more likely than women to rise to the highest paying and most prestigious leadership roles.

AAUW continues to strongly believe that our commitment to Education and Training, Economic Security and Leadership will further girls and women in all of society. To remain a cutting-edge and forward-thinking organization for today and tomorrow, AAUW must commit to best practices in Governance and Sustainability.

The Elgin Area Branch AAUW membership needs to continue to support empowerment of women and girls locally. Our capability to award scholarships to local college students needs to continue. Marlene Daubert and I are completing our terms as co-presidents. We have accepted a one-year extension to our term. We want to encourage our members to assume leadership positions in our AAUW Elgin Area Branch. There is plenty more work to be done.

**Climate Change Solutions

The Gail Borden Library will be hosting Elgin Green Groups350's showing of Project Drawdown's Climate Solutions 101 series starting in September! Watch the newsletter for details.

This series of professionally done videos from Project Drawdown, as they say, "is the world's first major educational effort focused solely on solutions. Rather than rehashing well-known climate challenges, Project Drawdown centers on game-changing climate action based on scientific research and analysis. This course, presented in video units (from 9-23 minutes each, and there are 6) and in-depth conversations, combines Project Drawdown's trusted resources with the expertise of several inspiring voices from around the world." And, to add a note from my favorite Earth Day/Month heroine, Greta Thunberg, the Swedish 18-year-old with

Asperger's syndrome, who bravely travels around the world to try to get us adults to "act like the adults in the room" also says: "No one is too small to make a difference."

Don't do what I did for about a year, listen to another extremist green group that says no individual actions will help, only governmental action. But the bottom line now is we need all actions from everyone. As Greta said, "No one is too small to make a difference," and Project Drawdown points out: energy efficiency in our homes and lives is a crucial part of the solutions!

## Public Policy Report Shirley May Byrnes

Many of the issues and bills mentioned in my May report are still active. Please review that list in addition to the following information.

**AAUW Washington Update:** These updates provide current information on bills that AAUW is tracking. The 5/13/21 issue covers The American Jobs Plan, the American Families Plan, and Pregnancy Workers Fairness Act.

**American Rescue Plan Act:** On May 10, the U.S. Treasury Department announced its **guidelines and allocation amounts** for ARPA's **Coronavirus State and Local Fiscal Recovery Fund**. Per the **Allocation for States table**, Illinois will receive over \$8 billion. Of this:

- \$2.46 billion will be allocated to **Illinois counties**
- \$2.73 billion will be allocated to **Illinois cities**
- \$742 million will be allocated to "**non-entitlement**" units of government (typically local governments with populations <50,000), which will need to apply via the state.

Also on May 10, **the FCC adopted rules** to implement the **Emergency Connectivity Fund Program**. This \$7.17 billion program, funded by ARPA, will enable schools and libraries to purchase laptop and tablet computers, Wi-Fi hotspots, and broadband connectivity for students, school staff, and library patrons in need during the COVID-19

pandemic. *ILA Alert - News from the Illinois Library Association, 5/13/21*

## Illinois Legislation

**Build Illinois Home Credit (SB2445):** This omnibus bill aims to address the shortage of affordable housing stock in Illinois by offering incentives to landlords who maintain qualified affordable housing properties and tax exemptions for the purchase of building materials to be used for the construction of new affordable housing units, among other things.

**Illinois Way Forward (SB667):** This bill would protect our communities from ICE by holding law enforcement accountable to follow state laws that limit police collaboration with immigration agencies and ensure access to legal protections promised under federal law for immigrant survivors of violence.

**HB 234 Media Literacy:** Would require media literacy to be included in IL high school curricula. Passed the House 4/20/21; has been assigned to Senate Education Committee and is scheduled to be heard 5/18/2021. *ILA Alert - News from the Illinois Library Association, 5/13/21*

**SB 101 Bd Higher Ed/Course Materials:** Would create the College Course Materials Affordability and Equitable Access Task Force and require public higher education institutions to study issues with textbook costs, including Open Educational Resources (OERs). Passed the Senate 4/21/2021 and has been assigned to the House Executive Committee. *ILA Alert - News from the Illinois Library Association, 5/13/21*

**Keeping Youth Safe and Healthy Act (SB 818):** This bill would create personal health and safety education standards in all Illinois public schools. It passed out of committee last week and is currently on the Senate floor. SB 818 creates personal health and safety standards for grades K-5 and updates and expands comprehensive sexual health education standards in grades 6-12 to give young people the information and tools they need to be safe and support responsible and informed decision making about their health and well-being throughout their lives. **HB3223 Ensuring Success in School:** Survivors of domestic violence, sexual violence, and gender-based harassment often endure lasting mental, physical, economic, and social consequences—and, as a result, experience a decline in academic performance. This bill provides success in school with appropriate, trauma-informed responses to the needs of every student.

**Parental Notice of Abortion (PNA) (SB 2190/HB 1797):** AAUW-IL is continuing to urge members to contact their state legislators about repealing the PNA. AAUW supports the right of every woman to access safe, affordable, and comprehensive reproductive healthcare, and this includes youth.

**SB 967, Senate Amendment 1,** sponsored by State Senator Cristine Castro, to address the maternal mortality crisis in

Illinois. It is hopeful that these new rules and policies will help people who give birth better outcomes. It passed unanimously in the Senate and has been sent to the House.

- **HB 25 - Immigration-Right to Counsel**, crossed over to Senate.
- **HB 119/SB516 - Healthcare-Prescription Drug Repository**, HB crossed over to Senate.
- **HB449/SB1707 - Housing is Recovery Pilot Program**, HB crossed over to Senate.
- **HB804/SB1718 - Clean Energy Jobs Act**, SB 3rd reading deadline is May 7.
- **HB 2775 - Homelessness Prevention**, crossed over to Senate.
- **HB2784/SB2117 - Mental Health, Community Emergency Services and Support Act**, HB crossed over to Senate.
- **HB3232/SB1840 - Hospitals-Financial Assistance**, SB crossed over to House.
- **HB3447 - Criminal Justice-Reducing Barriers to Recovery**, crossed over to Senate.
- **HB1736/SB647 - School Code: Sex Abuse-Sex Education**, recreated as a shell bill, SB818.

**Equal Pay Day Resolution (HR220):** Rep. Anna Moeller introduced this resolution on behalf of AAUW-IL. The resolution states that nationally women make 82 cents on the dollars for men. In Illinois, women make 81 cents on the dollar. Black women average 63 cents, Native American average 60 cents, and Latina women average 55 cents on the dollar. In Illinois, women are making 2 cents more than we made in 2020. In the 1970s, the average woman was making 59 cents to the dollar for men. We are making progress, but as we all know, it is much too slow. Please call your representatives to cosponsor and vote for House Resolution 220.

### Federal Legislation

**American Jobs Act:** This bill will invest heavily in education, housing, and public health to address the country's most pressing needs.

**Partnership for American Jobs Act:** This bill would create a grant through the U.S. Department of Education for public media organizations to promote local educational and workforce opportunities to their communities. Introduced by Rep. Raja Krisnamoorthi (D-IL) and Rep. Dan Meuser (R-PA).

**Investing in American Workers Act:** This bill would establish a 20% tax credit for small and mid-sized businesses that increase spending on their workforce training programs, including apprenticeships, career services, literacy initiatives,

courses through career and technical education schools or labor organizations, or employer-sponsored programs such as an industry trade association. I'm working to ensure that we are upskilling employees and reviving the heartbeat of both our small businesses and the middle class.

**John R. Lewis Voting Rights Act (HR4):** This bill will directly tackle issues of racial discrimination at the ballot box by restoring and strengthening the protections of the Voting Rights Act (VRA).

**DEJOY Act:** This bill would ensure that the Postal Service cannot slow its mail delivery standards. Introduced by Rep. Raja Krisnamoorthi. Passed out of the House Committee on Oversight and Reform.
